Sir,

I am directed to request you to please refer to the above & to the discussion had with the CIT (Admn. & CO) and the Addl. CIT(Hqrs./Admn.), O/o Pr. CCIT(CCA), Bhopal on 03.02.2015, on the demands raised in the above referred letter.

The action taken/ proposed on the charter of demands submitted by you point wise is as under:-

1. The recast list of LDCs has been issued on 03.01.2015. Objections have invited till 27.02.2015. Consequent action will be taken in due course.
2. DPCs could not be convened on 21.12.2014 as APARs were incomplete. As DPCs were held subsequent to 21.12.2014, retrospective promotions not possible as per rules.
3. Pending APARs have been received. A Review DPC is proposed to be held on 06.02.2015.
4. Ceiling of 03 years has been waived. Consequently, there are more than 100 applications which are to be considered. The Cases are being processed. Data called for in some cases is still pending. Insufficient data makes it impossible to assesses to suitability of candidates vis-a-vis others.

5. The DSC meeting was held on 20.01.2015. Order granting financial upgradation was issued on 20.01.2015. Vigilance Clearance in respect of the 09 officials was received only on 23.01.2015. proposed to be held on 06.02.2015.
6. Matter regarding space is being considered. Metro walk work is being taken up on priority.
7. For transfer of officials in posted in Inv. Wing as per RJCM policy, modification in policy is proposed for discussion. To be taken up before AGT 2015 preferably in April 2015.
8. In respect of inter-state transfer of Inspectors adjustments possible have been made. However, transfer of Shri R.K. Koma stayed till 30.04.2015.
9. Transfer of Shri B.S. Meena being stayed upto 30.04.2015.
10. In view of huge shortage, transfer application of TA/STA/others on mutual ground may be considered in the AGT 2015 preferably in April/ May 2015.
